Curry College requires official transcripts from all previously attended colleges and universities to be fully admitted into the program of your choice. Arrange for sealed, official bachelor's degree transcripts to be sent to Curry College directly from the Institution. **PSL applicants – An official transcript reflecting an earned master's degree in an education-related discipline from an accredited university is required.** Follow the steps below to request transcripts from each of the schools that you attended.

REQUEST OFFICIAL TRANSCRIPTS:

There are multiple ways to request transcripts, and each college or university will have their own process. Typically, the easiest way to order official transcripts is:

- 1 Contact the Registrar's office at your previously attended school, either by phone, email, or through your university's website.
- 2 Submit a transcript request following that school's procedures. Most colleges and universities require a signature or other official request in writing. Many schools have a Transcript Request Form available to download on the Registrar's website. Some will allow you to order transcripts online.

Note: Some colleges and universities charge a small fee for official transcripts. Be sure to enclose your fee with your transcript request to avoid a delay in processing.

- 3 It can often take several days for a transcript request to be processed. When your transcripts are received, the Graduate Information Office will contact you, but if you have not received confirmation within 14 days, please contact us at **(617) 326-2110**.

How to Apply for Financial Aid:

- 1 Apply for a FSA ID.** Go to studentaid.gov to apply for a Federal Student Aid ID (FSA ID) to electronically sign your FAFSA. If you are a dependent student, your parent will also need to apply for a FSA ID.
- 2 File a FAFSA.** Go to studentaid.gov to file the FAFSA. To ensure that we will receive your information you must enter **Curry College's Federal School Code of 002143** in step six of the online form. After Curry College receives your information, additional documentation may be required. The most common request is due to a process called verification. Verification is a process for confirming information reported on the FAFSA. It involves the collection and review of additional documents specified by the Department of Education. Student Financial Services will reach out to the student through email and regular mail with requests for specific documents to complete the verification process. You will be notified by email. If you intend to use financial aid to pay the tuition, it is recommended that students complete the FAFSA no later than two weeks prior to starting class.
- 3 File Financial Aid Enrollment Form.** You will need to complete an [Enrollment Information Form](#) in order for Curry to determine your eligibility for financial aid.
- 4 Curry College will mail your financial aid package.** Once your FAFSA is complete and you have been admitted to a degree program, a financial aid award package will be mailed to you detailing the types of aid and amounts for which you are eligible. If you receive any type of outside financial assistance, you must inform Student Financial Services.
- 5 Register for Classes.** After you receive your financial aid award, please contact the Division of Continuing Education and Graduate Studies to register for classes. Academic advisors are available to assist you with selecting courses.

Federal Loan Requirements:

To be eligible to borrow funds under the Federal Direct Loan Program, you must:

1. File the Free Application for Federal Student Aid (FAFSA)
2. Be a U.S. Citizen or permanent resident
3. Not be in default on prior educational loans
4. Maintain satisfactory academic progress

The Federal (Title One) Teacher Loan Forgiveness Program:

If you and your school qualify, this program may provide loan forgiveness for eligible Federal Direct Loans. This is a separate program requiring separate forms and processes. The U.S. Department of Education will determine your eligibility for this program. Curry College is not responsible to verify your eligibility for this program. Please do not base your enrollment on this program, as it can be difficult to ensure qualification for government programs which are subject to reform and funding changes. **You must call 1-800-4-FED-AID to verify your eligibility or visit <https://studentaid.gov/sa/repay-loans/forgiveness-cancellation/teacher> for more information.**

The TEACH Grant:

The Teacher Education Assistant for College and Higher Education (TEACH) Grant Program provides up to \$3,772 a year in grant assistance to students who are completing coursework towards certain high-need fields. In order to be eligible for a grant, a student must submit a FAFSA form and sign an Agreement to Serve as a full-time teacher at certain low-income schools and within certain high-need fields for at least four academic years within eight years after completing (or ceasing enrollment in) the course of study for which the candidate received a grant. Candidates must have at least a 3.25 GPA from undergraduate study and maintained a 3.25 throughout the academic program for which the TEACH Grant is received. The U.S. Department of Education and Student Financial Services Office will determine your eligibility for this program. The TEACH Grant converts to an unsubsidized Direct Loan if the student fails to complete any part of his or her obligation. This loan, plus interest, must be repaid. **For more information, visit studentloans.gov/myDirectLoan/launchTeach.action.**

Deferred payment option is available to continuing education students who are pursuing a degree program and can demonstrate that they have a tuition reimbursement benefit through their employer or the government. Students who qualify may pay their tuition at the end of each course, rather than upon registration. Students in this category are responsible for payment, and tuition may not be left unpaid pending reimbursement by an employer or other agency. Please contact the Continuing and Graduate Studies Office for further details and to complete a Deferred Payment Request Form. Graduate students may be eligible for a payment plan. The M.Ed. in Diverse and Equitable Instruction is designed for individuals who want to deepen their understanding of diversity, equity, and inclusion (DEI) in educational and professional contexts. This interdisciplinary program supports both licensed educators and professionals working outside of traditional K-12 settings.

What You'll Learn:

The M.Ed. program with a concentration in DEI gives educators across multiple settings an opportunity to develop more self-awareness and a deeper understanding of the current research and best practices for diverse and equitable instruction inclusive of all learners. Individuals explore multiple perspectives and frameworks that will provide the with a comprehensive background in the critical aspects of DEI. Graduates will have the ability to:

- Design and implement culturally responsive emotional practices that respect and celebrate diversity and inclusion
- Understand the principles of neurodiversity and assess and support neurodiverse learners through tailored educational strategies.
- Integrate SEL principles into their teaching, fostering students' emotional well-being and social skills alongside academic achievement.
- Advocate for social justice within educational settings, using their knowledge of equity, ethics and educational law to challenge systemic inequalities.
- Lead initiatives that promote diversity, equity, and inclusion in schools, influencing policies and practices to create more equitable educational systems.

This is a non-licensure track; however, Massachusetts teachers with an initial license can use the 12-credit option form to obtain pre-approval from the Department of Elementary and Secondary Education to apply coursework from this program to a professional license. The decision to use credit from this program is a decision made by the DESE's Licensure Office.

How You'll Learn:

In Curry College's M.Ed. programs, you benefit from our cohort learning model, which allows you to nurture lifelong friendships and forge meaningful professional connections. As you complete your degree program with the same tight-knit group of peers, flexible online classes enable you to work and learn at the same time.

Career Outcomes:

This is an ideal degree for: recent graduates, paraprofessionals and classroom aides, career changers, and individuals with a passion for education.

The Master's in Elementary Education consists of 34 credits. The curriculum is **approved by DESE** and results in initial licensure in Elementary Education (grades 1-6). Through this program, students also meet the SEI endorsement required by the Commonwealth of Massachusetts. Coursework is not approved by DESE to move individuals with initial licenses to professional licenses. Courses are taken in a structured sequence and thoughtfully designed to build knowledge and confidence.

In addition to hands-on, experiential teaching in a classroom, you'll explore key concepts of effective educational practice, including literacy, curriculum development and lesson planning, classroom management, working with children with disabilities, and strategies for adapting and differentiating instruction for diverse learners.

This certificate is designed for those special educators and support staff interested in a deeper understanding of Autism Spectrum Disorders (ASD). Meeting the standards and competency requirements for the Department of Elementary and Secondary Education (DESE) Autism Endorsement, this program will address the complex needs of students with ASD in a variety of school settings, across age and grade levels, and ranges of academic and behavioral functioning. Students who do not seek endorsement will receive a certificate of program completion issued by Curry College.

What You'll Learn:

The Center for Disease Control and Prevention (CDC) estimate that 1 in 68 children in the United States have been identified with Autism Spectrum Disorder. Advocacy groups such as Massachusetts Advocates for Children and Advocates for Autism of Massachusetts have pushed legislation to protect students with autism and to promote equal education and life opportunities for individuals with ASD. Currently the endorsement is voluntary however, school officials may require the Autism Endorsement in addition to basic licensure to ensure that schools can meet the unique needs of students in the least restrictive environment.

How You'll Learn:

High-Tech, High-Touch, High-Quality: Our unique online format allows you to attend synchronous online classes and gives you the freedom to form valuable connections no matter where you are.

Career Outcomes:

For:

The Curry College Principal and Supervisor Licensure Program (PSL) is a unique training opportunity for aspiring school administrators. Candidates are required to hold a Massachusetts educator license, have at least three full years of employment in an executive management/leadership role or in a supervisory, teaching, or administrative role in a public school, private school, higher education, or other educational setting accepted by the Department. Interested students are required to be working in a DESE-approved school, and have a mentor who hold the license they are seeking.

What You'll Learn:

The Principal and Supervisor Licensure Program focuses on linking best practice with theory to achieve measurable, real-world performance goals. Our program will prepare candidates for one of the following leadership roles:

- Principal/Assistant Principal Licensure (Pre-K – 8 and 5-12), or
- Special Education Administrator (all levels), or
- Supervisor/Director (level depends on prerequisite license)

Our program provides 550-hour Pre-practicum/Practicum supported by relevant coursework. Course assignments will require candidates to assume specific responsibilities in the school where they work as part of the Practicum. These performance assessments are aligned to the MA Professional Standards and Indicators for Administrative Leadership, to ensure that theory and practice are aligned.

How You'll Learn:

Classes are scheduled one evening a week and are delivered in a synchronous online format to best meet the needs of busy professionals. As a student in the Curry College PSL Program, you will be part of a cohort group. This means that the same students will be in all of your classes for the entire program, start to finish. Cohort group learning has proven to be very effective for adult learners because it creates a community of professionals who can study together, provide support, discuss common on-the-job problems, and offer networking opportunities.
